#### **IMPACT OF INDIAN PVP ACT ON CROP IMPROVEMENT SPACE**



- India is a signatory to both Convention on Biological Diversity CBD and World Trade Organization (WTO) conventions.
- ❖ TRIPS is an international agreement administered by WTO that sets down minimum standards and regulations of many forms of IP as applicable to WTO members
- **❖** As per GATT agreement ratification is compulsory requirement of WTO membership to obtain easy access to the numerous international markets
- Must enact the strict IP laws mandated by TRIPS

#### **INTERNATIONAL OBLIGATION UNDER TRIPS ARTICLE 27.3(B)**

Members shall provide for protection of plant varieties:

- **\*either by patents**
- or by an effective sui generis system one developed to suit each country's needs and priorities
- or by any combination thereof

Countries free to choose their own effective *sui generis* regime for protection of plant variety rights



### **Impact of PVP on public Sector**


- **Licensing** of IPR products to private sector companies and seed corporations and other organizations for commercialization

- Moving towards self sustenance for technology development and high-end research
- **Conserving PGR for sustainable use**
- **Strengthening public research for basic and strategic research**

## **Impact of PVP on Private Sector**


- Enhanced the participation of the private sector in varietal development research —
- PVP Provides the incentive of exclusive control for a specific period and thereby enabling to recover research investment
- Providing plant varieties IPR has led to a clearcut demarcation:
  - Upstream research sector
  - Downstream seed market
  - Technology commercialization (IPR licensing) market in the seed sector

# Overall progress of Registry since commencement of Plant Breeders' rights on PVP in India


#### Number of applications (17609) received Year wise:





#### Applications received (2849) and IPR granted (471) category wise in Horticulture





#### Application received - crop wise in vegetable (1990)




#### IPR granted in Vegetable crops (397)








### Maize and cotton dominated by private sector

#### **Revenue generation strategy- Public Sector**


PVPs offer possibilities for public institutes to generate revenue

 Institutes may collect revenue by selling source seed (breeder's or foundation seed) of public varieties to seed producers

 Following the guidelines set by ICAR few Public institutes/universities have also entered into nonexclusive agreements that give seed companies access to breeding lines


 An additional possibility to generate revenue is through interaction with MNCs (AFTER GETTING APPROVAL FROM NBA) where germplasm may be shared in return for a share of royalties on any varieties eventually marketed (nationally or internationally)
